GENERAL TERMS AND CONDITIONS

ORGANISATION

The IAC 2022 Conference is organised by the mixed economy company NAUSICAA – CENTRE NATIONAL DE LA MER, having its head office at Boulevard Ste Beuve – BP 189 – 62203 Boulogne-sur-Mer, registered under n°378 074 744 at the RCS (Boulogne-sur-Mer trade register).

1. PAYMENT CONDITIONS

The prices written on the order form include all taxes. As soon as the order form is received and once the Conference Organisation Committee has agreed, an invoice will be addressed to the exhibitor or sponsor.

Payment conditions:

- Payment on receipt of invoice
- Late payment penalty: three times the legal interest rate
- In case of late payment, standard payment rate for recovery fees: €40
- Nausicaa does not consent to discounts.

Every payment should mention " IAC 2022".

2. CANCELLATION

Any cancellation should be done in writing and addressed to Nausicaá by post. Cancellation policy is indicated on website of IAC 2022 as:

Virtual Trade Show: until 30 September 2022, cancellation will be free; from 1st October 2022 on, cancellation fee will be 100% of the amount paid.

Face-to-face Trade Show: until 31st July 2022, cancellation will be free; from 1st August 2022 on, cancellation fee will be 100% of the amount paid.

3. FORCE MAJEURE

In the case of force majeure, the dates and/or location of the IAC 2022 Conference may be changed or the event cancelled. In case of cancellation by Nausicaá, the funds will be returned to the exhibitors and sponsors.

4. INSURANCE

Nausicaá assumes no responsibility or liability for damages that may occur for any reason to the displayed goods. Every exhibition equipment is under the exhibitor or sponsor's responsibility during the conference, installation and dismantling of the booths. The exhibitor or sponsor commits to purchase an insurance covering its booth content and any related equipment.

Either party recognises having purchased a liability insurance covering the damages she may cause to others.

5. DISPUTES

The present contract is ruled by French law. The French version is the only one enforceable against the parties, who explicitly recognise it.

In case of litigation, priority will be given to a peaceful resolution by the parties. Without an agreement in a reasonable period, the courts of Boulogne-sur-Mer are the only court of competent jurisdiction.
